Offense: 574.100.6B - B-66426-TORT/MAIM/KILL CAT TO THREAT/TERRORIZE

On 12/16/25, I, Detective S. Henn #2384 was assigned this case to assume the role of primary investigator. The initial report taken by Officer J. Bosshart #2861 referenced animal abuse conducted by Angel Ventura Ayala (DOB: [REDACTED]) against a cat belonging to Angel's girlfriend Sienna Aldabbagh (DOB: [REDACTED]). The details were reported as follows:

#### INITIAL REPORTING OFFICER STATEMENT

On 12/16/25 at approximately 0356 hours I, Officer J. Bosshart #2861, was dispatched to 1070 Wellness Pl apartment 517, Henderson, NV in reference to a family dispute.

Upon arrival I made contact with Sienna Aldabbagh (DOB: [REDACTED]) at her vehicle in the parking lot. Sienna stated that her boyfriend Angel Ventura Ayala (DOB: [REDACTED]) threw her cat and she wanted her cat back. It is a note Officers were out here for an earlier incident see report (25-22940) for further information.

Sienna stated, earlier in the night she was at the apartment to pick up her items and then left with her friend Hailey. She dropped her friend Hailey off at a hotel and drove back to the apartment. Angel sent her a video of him throwing her cat against the wall. She parked her vehicle in a parking spot outside of the apartment and looked for her cat. She was unable to find it. She attempted to contact Angel, but he was not answering.

Angels' friend was on scene and was being uncooperative with Police. Sienna showed me the video that was sent to her. I observed Angel outside of his apartment door holding up the cat. He was talking in the video and eventually threw the cat against the wall. The cat bounces off the wall and hits the floor. On 12/16/25 at approximately 0115 hours I, Officer J. Bosshart #2861, was dispatched to 1070 Wellness Pl, Henderson, NV in reference to a disturbance.

Rudy Garcia called in that he heard a female yelling and someone banging a stick. Rudy only heard this information and did not know how he would get additional information since he was not going outside.

Upon arrival I made contact with Angel Ventura (DOB: [REDACTED]) and his friend who did not identify himself outside of building 5. Angel and his friend stated that they were inside their apartment and heard rocks being thrown and when they came outside, they saw that Angel's passenger window on his grey pickup truck (NV/ALU280) was broken. Angel and his friend stated that they did not know or see who threw the rocks and they do not have any enemies or anyone that would break his window.

While trying to investigate the vehicle damage, Angel and his friend both became uncooperative and did not want to talk to Police. Angel stated that he did not want a Police report and would get the repairs done himself. Angel then got into his vehicle and drove it away.

I observed another Silver Pickup truck (NV/55J738) that had damage to the rear window of the pickup truck with small rocks on the bed of the truck. I made contact with the registered owner at apartment 521. Kevin Foss (DOB: [REDACTED]) stated he did not know of anyone who could have done that to his vehicle. Kevin was unaware of the situation and was asleep when it happened.

I observed two gold hoop earrings on the ground. One earring was located in the parking stall between the two pickup trucks that were damaged, and the other one was located in the rocks next to the entrance of the staircase to the building. I also observed many small rocks located near the vehicles that were damaged. The rocks were consistent with the landscaping rocks around the complex.

I canvassed the area for video cameras which resulted in negative results. Officer Braun took photographs and later uploaded them into SAFE.

At approximately 0356 hours, I was dispatched to apartment 517 in reference to a dispute. Upon arrival I made contact with Sienna Aldabbagh (DOB: [REDACTED]) at her vehicle in the parking lot. Sienna is Angel's girlfriend and she was calling to report that Angel sent her a video of him throwing her cat. See report (25-22942) for further information.

Sienna stated that earlier in the night she came over to the apartment with her friend Hailey to pick up her belongings. While she was there her and Angel began to argue. She was in her vehicle parked in a parking stall and Angel parked his vehicle behind hers and got out. Angel walked up to her window which was closed and threatened to smash her windows with the bat. Hailey was out of the car and began to throw rocks at the vehicle because she was scared. She got in the vehicle and Sienna reversed out of the spot and drove Hailey to the Casino for an event.

#### DETECTIVE INVESTIGATION

On 12/16/25, upon case assignment, I reviewed the initial case details referenced above. I then made telephone contact with Sienna to obtain additional details. Sienna stated the following in summary:

Sienna and Angel had been in a dating relationship for approximately three (3) months. On the night of 12/15/25 into the early morning hours of 12/16/25 Angel and Sienna had gotten into a verbal argument due to Sienna having attended a party in a male friend's hotel room.

At approximately 0107 hours, Sienna received a video sent to her phone of Angel violently throwing her cat against a wall and again into the parking lot of his apartment complex. Still images from the video were captured and are shown below:

Sienna also stated that Angel had later posted a video on his Instagram (@guero702a) of the cat. In the video, the cat could be seen in a vehicle riding on the lap of a female (identified by Sienna as Valeria, Angel's sister Vallerye). The alleged driver of the vehicle was Angel. This video was posted at approximately 1200 hours on 12/16/25.

#### REVIEW OF CAT VIDEO

A copy of the video in which Angel can be seen throwing the cat was obtained and reviewed. A summary is documented as follows:

In the video, Angel can be heard speaking to an unknown individual recording. Angel said "you got this right" as he is picking up the cat as though he was making sure that the subject was recording. He then says "I'll throw your bitch as cat" as Angel walked out of his apartment and into the breezeway. As Angel walked down the breezeway, he violently threw Suki against the wall toward the parking lot. Angel then picked up the cat a second time and threw it into the parking lot. The cat could be heard crying during the second throw.

The video then ended.

#### ATTEMPTED CONTACT OF ANGEL

At approximately 1430 hours, I, along with Det Gutierrez responded to the suspect's residence located at 1070 Wellness Place Apt 517 in an attempt to contact Angel. The attempted contact at the door was negative so we began covert surveillance at the apartment in anticipation of his return.

Four probable vehicles were identified as belonging to Angel or Angel having regular access to:

1. Light blue Honda Accord bearing NV license plate LVJ73E
2. Black Chevrolet Camaro bearing NV license plate 4LM4
3. Gray Chevrolet Silverado bearing NV license plate AL4G18
4. Primer gray pickup truck bearing NV license plate ALU280

The only vehicle located at the Wellness Place address was the primer gray pickup.

A possible address for Angel's parents and sister was located as being 5251 Gains Mill St Las Vegas, NV 89122 which was identified by vehicle registration information.

Det Gutierrez went to the Gains Mill address where he located the Silverado, Honda, and Camaro. I proceeded to the Gains Mill address to begin surveillance at that location.

While surveilling the home, we observed a tall slender Hispanic male and a short female with dark hair exit the residence and enter the Silverado. They left the residence and were surveilled driving back to Wellness Place.

We continued to surveil the subjects and observed them exit the vehicle and wander the parking lot toward Angel's apartment. They never entered the apartment and walked back toward the truck.

At that time, I received a text message from Sienna who provided additional and unknown information which caused me to terminate the surveillance. Sienna stated that while looking for the cat near Angel's apartment, Angel pulled a gun from his waistband, racked a round and threatened her with it. That allegation was later documented under Henderson PD case number 25-23139.

In light of the new allegation of a gun being involved, Det Gutierrez and I discontinued surveillance.

12/16/25 at approximately 1600 hours a call for service was placed to alleged vandalism. The person reporting, Vallerye Ayala, stated that the interior of her brother's apartment had been vandalized by Sienna. Her brother was identified as Angel Ayala. Vallerye was accompanied by her boyfriend, Manuel Juarez (DOB: [REDACTED]).

Officers C. Nunez #2679 and M. Jordan #3162 were the first to respond followed shortly after by myself and Det. Gutierrez.

Vallerye wanted to report vandalism to the interior of her brother's apartment along with one of his vehicles, a primer gray pickup truck bearing NV license plate ALU280. It was established that Vallerye does not live or have residency at the Wellness Place apartment nor was she the registered owner of the truck. She was advised that her brother Angel, being the victim of the alleged vandalism would have to file the reports. Vallerye also mentioned that her brother was concerned about being doxed by his ex-girlfriend on social media. Specifically, she showed an Instagram post on her phone which stated "ANIMAL ABUSER AND ILLEGAL IMMIGRANT AT 1070 WELLNESS PLACE".

While flipping through Instagram, she also showed a copy of the video of her brother, Angel, throwing the cat. Vallerye stated that she wasn't defending him and knew he did some bad things, but Sienna has done bad things too.

I then asked Vallerye about the location and condition of the cat. She stated that she took the cat to the vet and that the cat was fine. She provided the name of the Veterinary office as being Pebble Maryland Animal Hospital. Detective Gutierrez called the animal hospital to verify the condition and location of the cat. He was advised that the cat was discharged and given back to Vallerye.

Myself and Gutierrez then reapproached Vallerye and stated that we needed to physically see the cat to verify its condition. She stated that the cat was at the home she shares with her parents and was reluctant to provide the address or allow us to see the cat.

I made it clear that the cat needed to be produced in person and she agreed to pick up the cat and return to our location. Vallerye then left and returned approximately 15 minutes later with the cat along with documentation provided by the animal hospital.

When she returned with the cat we advised that the Henderson Police Department would be taking temporary custody of the cat which would be turned over to the City of Henderson Animal Protection Services (APS) to be examined by our veterinarian and later returned to its legal owner.

Vallerye stated that she owns the cat to which I stated that legal ownership is yet to be determined.

Custody of the cat was taken and later turned over to APS Officer R. Clemente #2002 who transported the cat to the Henderson Animal Shelter for a veterinary examination.

#### BODYCAM REVIEW OF INCIDENTS

Incident # HPD251216000030 – 12/16/25 @ 01:18 hours

Officer Bosshart:

Upon arrival, Officer Bosshart made contact with two male subjects in front of building 5. The first male, a light skinned Hispanic male was wearing a brown jacket with "Dickies" logo over a grey hooded sweatshirt and a black baseball cap. The male stated that he came outside of his apartment and saw some females throwing rocks at his and his friends car. Bosshart asked if he had beef with any females and he said no. Bosshart asked if he had a girlfriend or ex-girlfriend who might do that and he said no.

That male identified himself verbally as Angel Ventura (DOB: [REDACTED] and social security number [REDACTED]).

The second male (who refused to identify himself) was a Hispanic male with a goatee style mustache and beard wearing a dark color sweatshirt which was pulled up exposing a sleeve of tattoos on his right arm, black baseball cap, and a black Nike Air Jordan backpack and a gold chain. This male was uncooperative and recording the officers with his cell phone and refused to give a statement.

Angel refused a report and moved the primer color truck which was parked in a handicap spot. Both Angel and the unidentified male went back into apartment 517.

Officer Bosshart observed visible damage consistent with being struck by small stones to the passenger window of a primer gray pickup truck NV/ALU280 as well as a gray Dodge Ram NV license plate 55J738 registered to Kevin Foss in apartment 521.

Bosshart made contact with Kevin who stated that he did not know who damaged his vehicle or why. Bosshart took a report for the vandalism to Foss' truck under DR 25-22940.

Incident # HP251216000078 – 12/16/25 @ 04:03 hours

At approximately 0400 hours, Officer Bosshart responded back to the target location where he made contact with Sienna who wanted to recover her cat.

Sienna stated the following in summary:

She had been in a verbal argument with Angel at the apartment complex. She was accompanied by friends who she did not identify. During the argument, Angel threatened Sienna with a baseball bat. As she drove away, Angel threw the bat at Sienna's car, but there was no visible damage. Sienna stated that her friends threw the rocks at Angels truck.

Sienna showed the video of her cat being thrown to responding officers.

Also present was and outside of the apartment was the same unidentified Hispanic male mentioned above. Bosshart asked the male about the cat, to which he said that the vandalism is a much bigger deal. The male then asked if Bosshart was going to get serious about the cat or vandalism and Bosshart said "both". The male denied recording the video or being the laughing voice in the background.

Bosshart asked where Angel was, and the male said, "Who's Angel?" It should be noted that Angel and this male were clearly contacted together as documented earlier in bodycam footage.

It was clear that the unknown male subject was being evasive in his speech, conduct and demeanor. He was reluctant to identify his friend and continuously made conflicting statements about the vandalism and the cat.

Officer Bosshart and Quintanilla then attempted contact at Angel's apartment (517) but no contact was made. As they reapproached the subjects, the male can be seen at Sienna's vehicle (which she was inside). At that time, Bosshart directed him to separate from her while they conducted their investigation.

The male left the scene.

During additional questioning, Sienna stated the following: Angel and his friend (whom she couldn't/wouldn't name) were at the apartment. Sienna was planning on going to a party with her friend Hailey and Angel got upset. It was then that Angel sent her the video of him throwing her cat. Sienna and Hailey came back to the apartment to try and get her cat and pick up other belongings in Angel's apartment. When they arrived, Sienna began looking for her cat and Hailey (allegedly) began throwing rocks at Angel's truck.

Sienna stated that she did not know Haileys last name and provided phone number 702-251-7458.

Sienna got back into her car at which time Angel and his friend came out of the apartment. Angel allegedly had a bat and later threw the bat at her car as she

and Hailey drove away. There was no visible damage to the car.

Sienna then dropped Hailey off at a hotel and then returned to the apartment where she sat in her car before calling the police for assistance.

Officer Bosshart documented the video and allegations which were forwarded to Animal Protection Services and Henderson Police Investigations for follow-up.

HAILEY (702) 251-7458

On 12/17/25 I attempted to call Hailey at 702-251-7458 to obtain a statement. The phone number provided was out of service.

Utilizing law enforcement resources, a records check of the target phone number was conducted which resulted in a low probability match to a subject named Corey Egan. Corey is a 62 year old male residing in Arkansas.

It is my belief that Sienna provided false information as to the identity of her friend to protect her from possible prosecution for vandalism. At the time of this report, Hailey remains unidentified.

#### PEBBLE MARYLAND ANIMAL HOSPITAL

On 12-17-25, Det. Gutierrez responded to the Pebble Maryland Animal Hospital, located at 1247 E Pebble Rd. LV NV 89123. Det. Gutierrez met with Veterinarian Carolyn W. Garcia D.V.M. (██████) who provided the following facts:

- On 12-16-25, a male domestic short hair kitten by the name of Chip was brought in by Vallerye Guevara Ayala, with an address of 5251 Gains Mill St., LV NV 89122, for an examination, as reflected on Invoice# 546153/ client ID# 48840.
- Dr. Garcia described Vallerye as a young Hispanic female adult (HFA) with dark hair wearing eyeglasses who was accompanied by a young Hispanic male adult (HMA) with dark hair and average weight.
- Vallerye stated that they found the cat at the park and requested that it be scanned for a pet microchip.
- Dr. Garcia noted that Chip appeared to be healthy but noted that she did observe bruising on the lower gumline and slight swelling to the chin.
- Vallerye expressed concern regarding the injuries.
- Dr. Garcia explained that the injuries were consistent with trauma, possibly being struck by a vehicle.
- Vallerye stated that chip may have fallen from a tree as that is where they found it.
- The examination was completed and Chip did not remain overnight.

Dr. Garcia advised that she would email me her examination notes and complete a witness statement at a later time today. Dr. Garcia also texted photos of Chip while at the animal hospital. One of the photos does display some type of redness or swelling to the mouth area.

A written and signed witness statement was received from Dr. Garcia which was attached to this report.

#### HENDERSON ANIMAL PROTECTION (VETERINARY REPORT)

An examination as completed on 12/17/25 at approximately 2:20 pm by Tessa Kronbetter. The examination noted injuries and inflammation to the mandibular region with lesions on the tongue. Complete xrays were taken and no fractures were present.

#### ANGEL AYALA VENTURA – CRIMINAL HISTORY

A records check of Angel was conducted and no known criminal history was located.

#### ARREST

On 12/18/25 I received a phone call from Sienna's grandmother, Hilary Aldabbagh. Hilary stated that she was worried about Sienna because her whereabouts were unknown. Hilary said that the family last heard from Sienna on 12/17/25 at approximately 9:00pm. At that time, they believed that Sienna went back to be with Angel at his apartment. Sienna's phone was also going straight to voicemail, and her location tracking was turned off. That behavior was very unlike Sienna.

Hilary was able to provide a GPS location for Sienna's vehicle which was mapping in the area of 4072 E Meadowglen Ave Las Vegas, NV 89121.

Due to the likelihood of Sienna being in the company of Angel, Detectives C. Gutierrez, D. Clarke, and Sgt L. Gornichec responded to the area to conduct surveillance on the vehicle. At approximately 1330 hours, Det Gutierrez observed the primer gray pickup truck known to be driven by Angel arrive at the location. Also in the vehicle was Sienna.

Angel was easily identified by detectives on scene due to him wearing the same baseball cap worn in the cat throwing video along with his light skin tone and the unique primer gray pickup truck with a damaged passenger side wide.

Angel and Sienna exited the truck and walked toward Sienna Mercedes where detectives contacted Angel and took him into custody.

#### PROBABLE CAUSE

During the course of my investigation I was able to determine the following facts:

1. Angel Ventura Ayala and Sienna Aldabbagh are in a dating relationship of approximately three (3) months.
2. On 12/16/2025 Angel and Sienna got into a verbal argument about Sienna attending a party in a hotel room.
3. On 12/16/2025 Angel sent Sienna a video of him throwing Sienna's cat against a wall then picking up the cat and throwing it a second time toward the apartment complex parking lot.
4. In the video, Angel can be heard speaking angrily toward the individual recording it saying, "you got this right" as he is picking up the cat as though he was making sure that the subject was recording. He then says "I'll throw your bitch ass cat"

Due to the above facts, I determined that the actions taken by Angel during the early morning hours of 12/16/25 when he picked up the cat while confirming that he was being recorded and saying "I'll throw your bitch ass cat" were an intentional and unlawful act conducted with the intention of causing fear and emotional distress to Sienna.

I've determined that probable cause exists for the class B felony offense of Torture/Main/Kill Animal/Dog/Cat to Threat/Terrorize, NRS 574.100.6B.

Angel Ventura Ayala was booked accordingly.
